

## Information on Data Protection

Dear DGPPN Member,

As a member of the German Association for Psychiatry, Psychotherapy and Psychosomatics e. V. (DGPPN) you benefit from various opportunities to receive information and participate in events and continuing education that are offered year in, year out. At the same time, you have taken on membership responsibilities, including payment of the membership fee determined at the general assembly. As part of this membership, according to the EU General Data Protection Regulation (GDPR, 2016/679) and the new provisions of the German Federal Data Protection Act (Bundesdatenschutzgesetz, BDSG) we are obliged to inform you about the purposes for which we collect, store or share your personal data. We are happy to comply with this obligation and thus would like to inform you about the following:

### **Data processing:**

In order to perform our association work, which fulfils and promotes the statutory purposes of the association, we process a large amount of personal data from you. Data are mainly collected to ensure that the association work can be performed, to establish and manage memberships, to charge and collect membership fees, to convey information to you via digital channels (newsletter) and print media and to fulfil the obligations of the association, including third party rights.

For these purposes we process your personal data, in particular your name, address, telephone number and other contact information (e.g. email), bank details, etc. Of course, your data are always kept strictly confidential.

### **Data recipients:**

We only share your personal data with third parties if this is permitted by law, your membership

requires it for other reasons or you have consented to it. Recipients of your data may be, in particular, higher-ranking associations (AWMF), other association members, publishers, cooperation partners, cloud services and others. Data are conveyed only for purposes related to your membership and to ensure the association can fulfil its obligations.

**Data storage:**

We will store your personal data for as long as is necessary to provide our services to you and for the duration of your membership. Longer storage periods may be required because of legal requirements.

**Your rights:**

You have the right to obtain information about the personal data relating to you (Article 15 GDPR). You can also request that inaccurate personal data are rectified (Article 16).

Furthermore, under certain conditions you have the right to erasure of data (Article 17 GDPR), the right to restrict data processing (Article 18 GDPR) and the right to data portability (Article 20 GDPR). Your data will be processed according to legal regulations (Article 6, Paragraph 1, Points b, f GDPR). We only need your consent in exceptional cases. In these cases, you have the right to revoke your consent for future processing at any time.

According to Article 21 GDPR you have the right to object to processing of personal data that have been processed according to Article 6 Paragraph 1 Point e or f.

You also have the right to lodge a complaint with a supervisory authority if you think that the processing of personal data relating to you is not lawful (Article 77 GDPR).
